

Giveaway Terms and Conditions

1. Introduction

By entering the \$10,000 Giveaway (the “Giveaway”), you agree to abide by these Terms and Conditions, which govern the Giveaway and are binding upon all participants. The Giveaway is sponsored and administered by DZINLY LLC (“Sponsor,” “we,” or “us”).

2. Eligibility

The Giveaway is open to legal residents of the United States, who are 18 or older at the time of entry.

Employees, affiliates, immediate family members of the Sponsor, professional accounts, businesses are not eligible to participate.

The contest is limited to homeowners within the United States. The Giveaway is subject to all applicable federal, state, and local laws and regulations and is void where prohibited.

3. Giveaway Period

The Giveaway entry period begins on August 6, 2025 at 12:00am and ends on December 31, 2025 at 11:59pm (the “Giveaway Period”). Start an account on dzinly.com, upload their home picture/plans and create at least two design options to share with the community. The project must then be shared to the community through

your toggle page. This share option can be found in the 'Value Added Services' section on your toggle page.

Any fraudulent, incomplete, or duplicate entries will be disqualified.

5. No Purchase Necessary

No purchase or payment is required to enter or win. A purchase will not increase your chances of winning.

The images must be on a flash drive in either .JPG or .PNG format. Images must be 1200 x 800 pixels with a minimum resolution of 72 DPI
